

AFFIDAVIT

I/We swear that I/we an/are the SOLE owner(s) of the business as described, that the premises specified in this application comply in all respects with the requirements of the Illinois Liquor Control Law and Commission Rules and Regulations and the Resolutions and Ordinances of Christian County, Illinois, and that I/we am/are resident(s) of Christian County and am/are qualified and eligible to obtain the license applied for herein under the Illinois Liquor Control Law and under the Christian County Resolutions and Ordinances referred to above.

I/We swear that I/we will not violate any of the laws of the State of Illinois or the United States of America, or of the Resolutions and Ordinances of the County Board of Christian County, Illinois, in the conduct of the place of business described herein and that the statements contained in this application are true and correct and are made for the purpose of inducing the County of Christian to issue a license herein applied for.

I/We further swear that I/we agree to all the terms and conditions of the Resolutions and Ordinances of the County Board under which this application is made, and agree not to sell or offer for sale at retail any alcoholic liquor in the County between the hours of 12:00 o'clock midnight and 6:00 o'clock in the morning of any weekday, or until 12:00 o'clock noon on Sunday, except that establishments for the retail sale of alcoholic liquor duly licensed pursuant to the terms of the resolution shall be permitted to remain open until 2:00 am of the following morning on Friday and Saturday nights and on all nights preceding holidays, and Daylight Saving Time shall govern the hours of all licensed establishments when in effect throughout the State of Illinois, and that I/we will not have, possess, keep or permit in said place of business any slot machines, any punch boards, or any game of chance.

I/We specifically further agree that every act or omission of whatsoever nature constituting a violation of any of the provisions of the resolution, by any manager or other agent or employee of any licensee, if said act is committed or omission is made with the authorization, knowledge, approval or acquiescence of the licensee, shall be deemed and held to be the act of such employer or licensee, and said employer or licensee shall be punishable in the same manner as if said act or omission has been done or omitted by him personally.

I/We further specifically agree that it shall be a specific provision of every license to be issued hereunder, that the Sheriff, or any law enforcing officer duly designated by him and any regular member of the Sheriff's force of the County, any duly authorized person charged with the responsibility of enforcing the laws of this State and the Resolutions and Ordinances of this County, and any member of the Liquor Committee of the County Board of Christian County, shall at any time or times have, and the County hereby reserves for itself the right, and any person accepting a license under the provisions of the resolution, hereby specifically agrees that they shall have the right at any and all times without warrants of any character to enter upon and search any premises licensed hereunder, in order that they may determine whether the provisions of the resolution have been or are being violated, and such Sheriff or other proper officer shall have the right at any time to examine the premises of the licensee.

I/We further specifically agree that all licenses are mere revocable and conditional permits. The County Clerk and Chairman of the County Board, or that person duly appointed to assist said Chairman of the County Board, may at any time recall and annul any license, whether expired or not, and that the County Clerk, and the Chairman of the County Board, or any person or persons duly appointed by him/her to assist him/her, or the County Board may revoke any retail liquor dealer's license for any violation of any provisions of the resolution, or for any violation of any State law pertaining to the sale of alcoholic liquor.
