Item #1: Drainage District Construction Rules and Requirements

He stated the language adds clarity for all parties and helps Commissioners to protect the drainage assets. If these rules would have been in place it would have helped prevent the situation with CTI laying fiber optics along County Highway 6 which crossed 5 different drainage districts. The easements required to lay the fiber optics had to be filed with the Court, public notice given, a public hearing held and approved by the Judge.
